

Terms & Conditions



- ❖ The competition is open to perfumers of any nationality, members or not of the BSP, who wish to showcase their creativity.
- ❖ In case of very high number of entrants, the BSP reserves the right to limit them to a total of 200 participants.
- ❖ Priority will be given to BSP members and members of other societies of perfumers.

 Independent perfumers are welcome to participate but will need to provide evidence of their skill level and to attach a CV with their application form.
- Members of the judging team and Ultra employees are excluded from entering the competition.
- ❖ The entrant may only submit a single perfume to the competition and must declare that it is their own personal creation and that it is not available in any market.
- The story of the fragrance creation, its inspirations and the notes that compliment the Patchouli oil must also be submitted with the fragrance. The panel will appreciate if your creation story includes the use of other Sustainable materials such as: Upcycled materials, Other naturals with Fair for Life certification and a Green Chemistry or bio synthesis story you can tell for an aroma molecule.
- ❖ The fragrance should be male, female, or gender neutral, designed for Eau de Toilette (EDT) at 15%.
- ❖ All submissions must conform to current IFRA guidelines at the use level. A declaration of conformance to IFRA guidelines for category 4 at 15% must accompany the entry.
- ❖ Entries must be supplied as a concentrate and alcohol will be added prior to judging by the BSP.
- ❖ All submissions may contain the following: essential oils, aroma molecules, absolutes and resinoids
- ❖ Submissions <u>may NOT contain</u> the following from outside sources: Pre-made accords, Bases and Captive ingredients



Terms & Conditions



- It is acceptable to use a personal base that the entrant has formulated
- The Raw Material Cost for the submission is not limited.
- ❖ The winner retains ownership of his/her fragrance and formula and may use it professionally with the title: «BSP 60th anniversary Winner»
- To remain anonymous until the qualification of the Prize-winner, a system of numbering will be attributed to every submission, in a random way.
- The competition organisers reserve the right to accept or reject entries if they do not comply with the conditions of the above rules or fail to meet the published deadlines for any of the stages of this competition.

Competition Timeline

- ❖ Launch date is at the BSP One Day Symposium 18th May 2023
- Final date to register for the competition is 1st July 2023
- ❖ Entrants will receive a pack with the Ultra Patchouli oil and further competition information
- *BSP to receive the final submission prior to November 30th 2023
- *BSP will communicate the short list to entrants by the end of March 2024
- *Winner will be announced at the BSP One Day Symposium May 2024

Judging

❖ The winning entries will be selected for creativity and originality in shining a new light on patchouli. The judging will be carried out by an independent panel of at least 5 fragrance professionals including BSP council members
